### Agenda Item #1 - Welcome and Introductions

### Agenda Item #3 - Consent Agenda

### Agenda Item #5 - Election of New Advisory Council Vice President

# <u>Agenda Item #6 – Contract Review Process – Request for Proposal OAA/LSP Chore Services, Pinellas County Only for 2024</u>

Ms. Christine Didion, Director of Program Accountability informed that the AAAPP had received writing notification from the Pinellas Opportunity Council, the current Older Americans Act provider for Chore Services in Pinellas County, that they will not be submitting a Continuing Application for OAA/LSP Chore services for the 2024 Contract Year. Ms. Didion presented the timetable for the Request for Proposal Contract review process to competitively secure a new OAA/LSP provider to provide Chore services beginning January 1, 2024. Ms. Miriam Benitez-Nixon made a motion to approve the timetable for the Request for Proposal Contract review process to competitively secure a new OAA/LSP provider to provide Chore services beginning January 1, 2024. Ms. Valerie Anderson-Stallworth seconded the motion. None opposed, motion carried.

### Agenda Item #6 - AAAPP 2022-2025 Strategic Plan Update

Ms. Winter informed that the Strategic Plan Consultant, Nina Berkheiser had passed, the AAAPP will be looking towards a new Consultant. ### Agenda Item #7 -2024-2027 Area Plan Development

Mr. Jason Martino, Director of Planning presented the 2024-2027 Area Plan cycle and the development process for Calendar Years 2024 – 2027. The presentation included an overview and highlights of the contents of the plan. There was discussion and questions which ensued, these were addressed by Mr. Martino. For information only, no action necessary.

Agenda Item #8 – Aging And Disability Vaccination Collaborative (ADVC) Grant Award Ms. Kerry Kimball Marsalek, Chief Operating Officer, reported that the Area Agency of Pasco and Pinellas, Inc. has been awarded \$447,360 in grant funding through USAging and funded by the Administration for Community Living. Ms. Marsalek stated this grant provides funding to support COVID-19 and flu vaccinations for older adults and people with disabilities. The AAAPP will partner with organizations to host community vaccine clinics, provide in-home vaccinations, coordinate transportation to vaccination sites, and conduct outreach and education to older adults and people with disabilities among other activities. The AAAPP will administer this grant in Pinellas and Pasco Counties through new partnerships with several organizations which include Meals on Wheels of East Pasco and Empath Health. These new partnerships will further expand our vaccine outreach. Additional vendors may be added as funding allows. For information only, no action necessary.

### <u>Agenda Item #9 – Application for New Advisory Council Member</u>

Chair Commission Eric Gerard presented for review an application from Sally Marvin a candidate for Advisory Council Membership. Sally Marvin is a resident of Pinellas County and the Director of the City of St Pete Sunshine Senior Center. She has 32 years of professional experience working with seniors. There are currently 3 open seats on the Advisory Council namely, Kimberly Shaw, Janet Hooper and Beth Aker who had now resigned her seat on the Council because her agency will now be funded by the AAAPP as of July 1, 2023. Chair Gerard informed that the

Nominating Committee made a motion to recommend that the candidate Sally Marvin to be presented to the Advisory Council for approval with Terms 2023-2024.

Ms. Miriam Benitez-Nixon made a motion to approve the election of Sally Marvin to the AAAPP Advisory Council. Ms. Barbara Epstein seconded. None opposed, motion carried.
