Overview

The Area Agency on Aging of Pasco-Pinellas and the Community Foundation Tampa Bay hosted a Senior Housing Roundtable Discussion in Pasco County, Florida on November 30, 2023. The objectives of this roundtable discussion were to (1) review seniors' unique housing needs, (2) determine actionable strategies to address senior affordable housing and homelessness, and (3) stimulate community stakeholders' consensus for collective action and impact.

Pasco County's Vision for Quality, Affordable, and Safe Senior Housing

Roundtable participants individually and collectively articulated their vision for quality, affordable, and safe senior housing and older adult housing security in Pasco County, Florida as follows:

- Senior housing is affordable or subsidized long-term without cost burden, positively contributing to elders' financial security
- Senior housing options include multi-faceted and one stop living communities with individualized, coordinated, and wraparound services
- Community inclusion and engagement with close proximity to necessities and amenities, aligning with AARP's livable communities' guidelines
- Ability for seniors to shelter and age in place
- Coordinated entry system with access for at-risk seniors including for homelessness diversion
- New and existing buildings/structures (*i.e., shopping centers that are retrofitted*) including vertical, mixed-use, and intergenerational designs
- Partnership and collaboration between community organizations, governmental agencies, and developers

Action Strategies

As a result of the November 30, 2023 Roundtable Discussion, the Area Agency on Aging of Pasco-Pinellas and its partners initiate this community action plan reflective of priorities and strategies to advance quality senior affordable housing in Pasco County. This plan is a "living" document that will be updated and can be revised as it is implemented.

- Increase in conversion of housing units and commercial spaces to senior residential properties
- Updated land use policies and zoning modifications supporting senior housing
- Decrease in housing cost burden on seniors
- Decrease in senior helpline calls focused on housing challenges and homelessness
- Decrease in homeless seniors
- Increase in long-term senior affordable housing funding and resource allocation
